IMPORTANT INFORMATION

Notice of Fingerprint-Based Criminal History Records Check

After July 1, 2018, all individuals licensed by the Mississippi Real Estate Commission (MREC) will have completed a "Licensing Cycle" in which a Criminal History Records Check based on the submission of fingerprints to the MREC was received. Beginning with the July 31, 2018 Renewal Date, applicants for renewal of any real estate license will NOT have to submit a new fingerprint card. The MREC will use your Original Card to submit to the Department of Public Safety and the Federal Bureau of Investigation.

Submission of Renewal Form, Criminal History Acknowledgment and Fees:

Enclosed with this Renewal Notice is an envelope <u>addressed to the MREC</u> for the return of the documents included in the mailing. If you mail the documents in a different envelope, please use the following address:

Please return the executed Renewal Notice (Signature required on the back of the notice) and the renewal fee in the form of a check or negotiable instrument. The renewal fee for a Broker is \$150.00 and the renewal fee for a Salesperson is \$120.00. Please return the completed and executed Consent Form along with a **separate** check or negotiable instrument in the amount of \$50.00. **Separate checks are required but each should be made to the MREC.**

When received, the MREC will electronically submit your <u>Original Fingerprint Card</u> to the Department of Public Safety Criminal Information Unit (CIU) to process a new background check of the Mississippi and Federal databases.
