REMINDERS FOR HOME INSPECTORS

- SUBMIT YOUR HOME INSPECTOR'S UPDATED CERTIFICATE OF LIABILITY INSURANCE <u>UPON THE RENEWAL OF THE POLICY</u>. EITHER YOU OR THE INSURANCE COMPANY CAN SEND THE DOCUMENT by email to: <u>hhood@mrec.state.ms.us</u>

[It is the <u>home inspector's PERSONAL</u> responsibility to submit this to our office; not the insurance company. However, the insurance company may send (e-mail or snail mail) the Certificate to the MHID. If we do not have a current Certificate of Liability Insurance on the date of your renewal, your license will be placed on inactive status and you will incur additional expenses (\$25.00 **inactive fee** and \$25.00 **reactivation fee**) to begin working again. While on inactive status you are not allowed to conduct OR participate in **ANY** home inspections and must surrender your license and pocket card until reactivation occurs.]

- SUBMIT YOUR PROOF OF COMPLETING 20 HOURS OF CE BY THE DATE OF YOUR RENEWAL OR WITH YOUR RENEWAL FORM. It is best to e-mail the certificates upon the completion of each course. IT IS <u>THE HOME INSPECTOR'S</u> <u>RESPONSIBILITY</u> TO SUBMIT THE CE CERTIFICATES; NOT THE PROVIDERS. YOU MAY E-MAIL THEM TO: hhood@mrec.state.ms.us
- ANY CHANGES OF ADDRESS, PHONE NUMBERS OR E-MAIL ADDRESSES SHOULD BE SUBMITTED TO THE MHID OFFICE IMMEDIATELY. YOU MAY E-MAIL ANY OF THOSE CHANGES TO THE SAME ADDRESS GIVEN ABOVE.

HOW TO SUBMIT A CHANGE OF ADDRESS:

Send a letter stating that you want a change of address. Include your <u>original wall license</u> and a <u>check in the amount of \$25.00</u> for the address change. The MHID will then reissue you a wall license reflecting the updated address change. Do NOT return the pocket card if you are only changing the address on your license.

<u>NEW HOME DESIGNATION REQUIREMENTS ARE:</u>

- You <u>must</u> have an <u>active</u> residential builders (contractors) license
- You must have an active certification with the International Code Certification Council (ICCC) in ONE of the residential courses below. There are no exceptions.

TO RENEW YOUR "NEW HOME DESIGNATION" YOU <u>MUST</u> SUBMIT PROOF OF THE FOLLOWING:

- 1) ACTIVE ICCC CERTIFICATION WITH AN EXPIRATION DATE THAT IS LATER THAN THE RENEWAL DATE OF YOUR LICENSE; and
- 2) ACTIVE RESIDENTIAL BUILDERS (CONTRACTORS) LICENSE WITH AN EXPIRATION DATE THAT IS LATER THAN THE RENEWAL DATE OF YOUR LICENSE.

FAILING TO PROVIDE THE PROPER DOCUMENTATION AT THE TIME OF RENEWAL OR AT THE TIME ANY CERTIFICATION EXPIRES IS A VIOLATION OF STATE STATUTE AND SUBJECTS THE LICENSEE TO POSSIBLE DISCIPLINARY ACTION, FINES AND/OR REVOCATION OF LICENSURE.

The MHIB considers a "New Home" as one that has not previously been occupied and MHID does not consider the date of completion or the issuance of a Certificate of Occupancy by any governmental entity in determining whether the property is a "New Home." Typically, the seller of a "New Home" is going to be the builder or building contractor. Newly constructed homes that have been occupied by "tenants or other individuals as a place of residence" prior to a change in ownership are NOT considered "New Homes" for purposes of Home Inspections in Mississippi.
