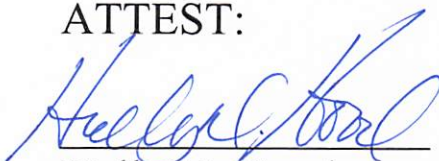
NOTICE OF SPECIAL CALLED MEETING OF THE MISSISSIPPI REAL ESTATE COMMISSION

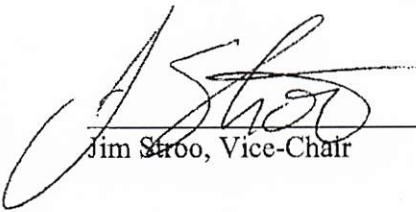
