



**Principal Brokers: Register the contents of your Cooperative Agreement online by logging into your license account at [www.mrec.ms.gov](http://www.mrec.ms.gov)**

**Things to know:**

- **DO NOT upload/send your Cooperative Agreement to MREC. Use the MREC online registry to register its contents.**
- **Only Principal Brokers can register a Cooperative Agreement.**
- **The Cooperative Agreement must be registered within ten (10) days from the latest signature date of the Cooperative Agreement.**
- **If the Co-op Agreement pertains to a specific property, property's location address (or legal description) **MUST** be documented.**
- **Register a separate Co-op Agreement for each property or entity.**


