You opt in to receiving informational text messages from MREC by providing us your cell/mobile number in the particular “Cell Phone” field for that purpose. If you do not provide a number in said field, you will not receive text messages from MREC. For example, you can provide your cell number in your “Work” phone field only, and you will not receive text messages.

Automated messages may be sent using an automatic telephone dialing system to the cell/mobile telephone number you provided in the Cell Phone field when updating or establishing your account profile.

Message frequency varies, and additional mobile messages may be sent periodically based on your interaction with MREC. MREC reserves the right to alter the frequency of messages sent at any time to increase or decrease the total number of sent messages. MREC also reserves the right to change the short code or phone number or alphanumeric sender where messages are sent. Your usual message and data rates may apply. If you have any questions about your text plan or data plan, it is best to contact your mobile provider. Your mobile provider is not liable for delayed or undelivered messages.

Cancellation

Messages will provide instructions to unsubscribe through an included link to access your account profile and remove your cell number from your Cell Phone field. After doing so, no
