

MINUTES
Mississippi Real Estate Commission
Special Called Meeting
July 30, 2026

The Mississippi Real Estate Commission held a Special Called meeting at 3:30 p.m. on Thursday, July 30, 2026, at the offices of the Mississippi Real Estate Commission, located in the LeFleur's Bluff Tower, Suite 300, 4780 I-55 North, Jackson, Mississippi. The following Commissioners were in attendance via conference call: Chairman Jim Stroo of the Fourth Congressional District, Commissioner Brian Gomillion of the First Supreme Court District, Commissioner Vicki Blackwell of the First Congressional District, Commissioner Daniel Case of the Second Supreme Court District, and Vice-Chair Tony Jones, Member-At-Large. Staff Members in attendance included Executive Director Bryan Lieb, MREC Legal Counsel William Hussey, Chief Financial Officer Victoria Prine, and Chief Operating Officer Holly Hood. The Special Called Meeting was noticed and convened as a meeting at the offices of the Commission and noticed as a meeting open to the public. No members of the public were present.

Chair Jim Stroo, recognizing a quorum of Commissioners present, called the meeting to order at 3:30 P.M.

Executive Session

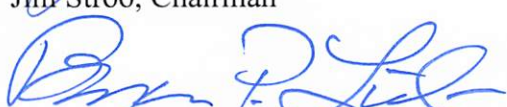

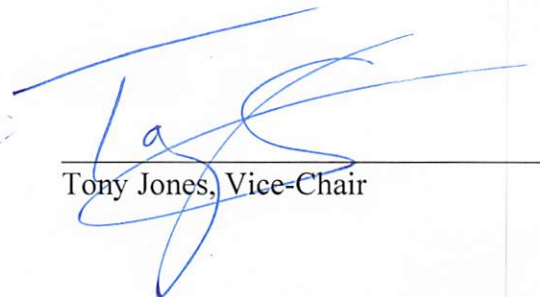
